Horn reviewed various items listed in the accounts payable. He encouraged the board members to come to the SPNRD office at any time to review the receipts and/or disbursements or ask any questions. The total amount of accounts payable is \$85,064.53. Horn mentioned that the Sixty Month CD with Security First Bank was closed into the SPNRD checking account. After discussion, Halligan moved to approve the Treasurer's Report and authorize payment of the accounts payable in the amount of \$85,064.53. A second was made by Narjes and with no further discussion a roll call vote was taken.

5. Overview of the Western Water Use Management (WWUM) Model and Analysis Review

The board requested Kuntz provided the aquifer life analysis for the last five years of the model. He ran three (3) pumping scenarios; 14 acre-inches/acre; 16.5 acre-inches/acre and average actual pumping from 2009 through 2013. He ran the model producing scenarios from 10 years through 500 years. He discussed adjustments he made for drawdowns in the Albin, Wyoming area. Discussion followed. Halligan asked why some of the scenarios showed increases in the water table (to make sure errors weren't made). He also requested using 5' grid (contours) instead of 25'. Kuntz addressed his request. Discussion was held that the model data indicates that allocations have worked. Halligan asked if actual pumping data is lower than the allocation; maybe the allocation should be lowered. The board requested a 10-acre-inches/acre model run that repeats the last 5-years of model recharge, 5 foot contour and cropping data (Glanz will supply Kuntz with the crop data). Discussion followed. Kuntz discussed using 2/3 saturated thickness verses actual depth to water. Kuntz plans to present the requested analyses during the June board meeting. South Platte River valley targets under the IMP were discussed. The model data will be used by the District's Ground Water Advisory Committees to determine allocation recommendations for the upcoming allocation period.

6. Director and Staff Reports

Glanz-worked on a replacement well south of Chappell. He and Reisdorff prepared the Basin-wide report, attended WWUM model meetings, planted trees on the lot and assisted with lot cleanup. He told the board that the GIS mobile app is being tested by collecting industrial flow meter data. He worked on the District's water usage report and ownership changes. He reported that the water recharge west pit is filling from the South Platte River on that permit that expires at the end of May 2015. He attended a well decommissioning and assisted with the Western Nebraska Children's Ground Water Festival (GW Festival).

Reisdorff-submitted the rough draft of the Basin-wide report. The Potter Wellhead Protection Area (WHPA) Plan was approved by NDEQ. The Village of Gurley board approved their WHPA Plan. He attended WWUM model, Platte Overappropriated Basin meetings and the Nebraska Floodplain and Stormwater Managers Association meetings. He prepared and participated in the LandscapeWise Urban BMP workshop which had the largest attendance since the workshops began. He participated in the GW Festival, assisted with SPNRD lot cleanup and tree planting.

Witrock-regarding the Conservation Tree Program, rain has pushed back tree planting so the cooler will be running for several weeks. Kent Matsutani and Randy Gunn were hired for seasonal employment at the ORRA. The reservoir should be covered each day of the week between the two employees. Picnic tables will be put out on May 15. Prestige Manufacturing is in the process of installing ten fire pit grills. He reported that the Lodgepole Creek wasn't flowing upstream of the reservoir; however; the reservoir level is up. Regarding the East Sidney Watershed Project, he discussed that the JESWA meeting will be held this week. The next step will be to agree to move forward with the design engineering phase of the project. State Historical Society requested an archeologist evaluate the watershed project. He participated in the GW Festival.

Ogle-participated in the Sidney Tree giveaway, prepared for and participated in the LandscapeWise Workshop and the GW Festival. He reported that 152 students participated. He performed website updates. The computer he was using crashed and a new computer was purchased.

Sanders-prepared flow meter maintenance cost-share, inspected new flow meters, read industrial flow meters, ultrasoniced at Sandpoint power records for Michael Reuter and assisted at the GW Festival.

Suhr and Horn submitted written reports.

## 7. Agency Reports

### A. USDA Natural Resources Conservation Service (NRCS)

#### 1. NRCS Report

Kristin highlighted portions of her May written report. She also enclosed a fact sheet regarding the 2014 Farm Bill crop insurance premium subsidies. Current Sidney Field Office Secretary, Jane Joyce submitted her resignation and will be moving to Lincoln in June. Miller and Suhr will be conducting interviews later this week to fill the vacancy. Miller discussed filling NRCS vacancies.

### B. Nebraska Association of Resources Districts (NARD)

#### 1. NARD Report

Johnson attended the last NARD meeting held in April. He participated in the Nebraska State Envirothon on April 29, 2015 south of Cozad. Eleven teams participated. Sidney won second place. The next meeting will be held in Gothenburg during the annual basin tour.

#### 2. NRD/NARD Employee Benefits Committee and NARD IRMP Association Loss Control Committee Reports

Johnson and Horn attended the meetings that were held April 22, 2105. Horn discussed progress of the committees and the insurance standing.

### C. Nebraska Department of Natural Resources (NDNR)

#### 1. NDNR Report

Rexroth plans to attend the next meeting in June. A rules committee will meet at the end of May.

8. Discussion Regarding Nebraska Education TV Natural Resources District History Project

This is an information item only. NARD is considering action during their June NARD Board meeting on a Nebraska Education TV proposal to produce a one-hour Natural Resources District history project at a cost of about \$70,000. An email string from Dean Edson was included with the handout information. Edson is requesting whether the natural resources districts are interested in pursuing this and whether they would be willing to contribute funding. A firm budget has not been made at this time; however, Edson is proposing contributions of \$3,000 per NRD. The board was in agreement to move forward with the project pending the final agreement and review by the board.

9. Requests Regarding Clean Harbors Citizens Monitoring Committee (CMC) recommendation to hire a Consulting Firm

A. \*Discussion and Ratification of the CMC request to hire Southwest Environmental Engineering

The District has a Cooperative Agreement with Clean Harbors Environmental Services, Inc. (CHESI) which became effective January 26, 1996. The agreement allows the District to monitor the environmental impact of the Kimball CHESI facility and provide for a monitoring committee (Citizens Monitoring Committee or CMC).

Discussion was held that CMC had most recently employed the services of MILCO Environmental Services, Inc. (MILCO), Jacque Reiner, P.E. until MILCO replaced her with a consultant who did not perform satisfactorily or in a timely manner. However, during the February 16, 2015 CMC committee meeting the committee voted to recommend termination of the agreement with MILCO and the SPNRD Board acted to ratify their action on March 10, 2015. Request for Proposals were prepared and two consulting firms were chosen from the applicants for interviews. After interviewing Tetra Tech, Inc, and Southwest Environmental Engineering the Citizens Monitoring Committee met on April 16 and again via conference call on April 23, 2015 to discuss and take action to recommend hiring Southwest Environmental Engineering to serve as their environmental consultant for the CHESI facility in Kimball. The CMC committee requested Southwest Environmental Engineering to provide a contingency plan because their office was small and staffed with only one professional engineer. During the CMC meeting on April 23, 2015 the committee reviewed the Southwest Environmental Engineering contingency plan and voted to move forward to hire Southwest Environmental Engineering and prepare a contract.

Motion by Halligan to ratify the request of the Citizens Monitoring Committee to hire Southwest Environmental Engineering as discussed. Second by Maas.

After discussion, a roll call vote was taken.

B. \*Ratification of the Contract between SPNRD and Southwest Environmental Engineering

The contract, prepared by SPNRD legal counsel was included in the handout information. The agreement for professional consulting services is between the SPNRD and Southwest Environmental Engineering. The Scope of Work, Exhibit B and Exhibit C - Fee Schedule and Not-To-Exceed Values based on the South Platte Natural Resources District's July 1 through June 30 Fiscal Years were discussed. Horn discussed increase of the fees by adding "not to exceed". CHESI provides a quarterly payment to maintain the Citizens Monitoring Committee.

Motion by Halligan to ratify the contract between the SPNRD and Southwest Environmental Engineering with Rod L. Horn, General Manager as signatory and designated representative for the District to direct all affairs with respect to the agreement with Southwest Environmental Engineering. Second by Narjes. A roll call vote was taken.

##### A. Natural Resources/Projects and Programs Committee

##### 1. Discussion concerning the Johnson/Smith Variance Request and Transfer Application as Requested by Pine Bluffs Gravel and Excavating, Inc.

##### a. \*Action on Variance Request

No members of the public attended the meeting regarding the variance request and transfer. A variance is necessary to transfer an irrigation allocation across subarea boundaries. The Johnson Brothers well is located at the SW¼ of Section 24, Township 12 North, Range 43 West, in the South Platte Valley subarea. 51.6 Certified Irrigated Acres (CIA) are associated with the Johnson Brothers well G-021605. The Michael R. and Jo Ellen Smith commercial industrial well is located at the SW¼ of the NE¼ of Section 1, Township 12 North, Range 44 West, in the fully appropriated subarea; both in Deuel County. Pine Bluffs Gravel and Excavating, Inc. requests to wash aggregate using the Smith well, G-074242. The Smith well has an industrial flow meter but does not have an industrial baseline; necessitating an offset. Similar variances have been approved in the past.

On behalf of the committee, Maas made a motion to approve the variance requested by Johnson Brothers to transfer their allocation from the South Platte Valley over-appropriated subarea to Michael Smith's industrial well in the Deuel County fully appropriated subarea. A second was made by Rutt. After discussion, a roll call vote was taken.

##### b. \*Action on Transfer Application

On behalf of the committee, Maas moved to approve the transfer request between Johnson Brothers and Michael Smith as requested with the following conditions:

- The industrial flow meter needs to be inspected by SPNRD staff before any water is pumped; and
- No water shall be pumped until a title search and any necessary lienholder's consents are received.

A second was made by Rutt. After discussion, a roll call vote was taken.

2. Discuss the City of Sidney's request to move 87.4 Certificated Irrigated Acres to the SPNRD's Water Bank to be used as future offsets for the City of Sidney through the SPNRD Administrative Process

Reisdorff explained the process and reasoning behind the request. The City of Sidney owns 87.4 CIA located in Section 33, Township 14 North, Range 49 West, Cheyenne County, in the Industrial Park east of Link 17J north of 21<sup>st</sup> Century Equipment. Gary Person was present during the Committee meeting and provided input. The City requests the acres be used to offset future municipal water use for the City of Sidney through the NRD administrative process.

On behalf of the committee, Maas moved to allow the City of Sidney to place 87.4 certified irrigated acres into the SPNRD water bank, which could be used in the future to offset municipal growth. A second was made by Rutt. After discussion, a roll call vote was taken.


